

ARE YOU AT RISK OF HOMELESSNESS?

- Do you live in San Mateo County, and you are in danger of losing your rental housing?
- Have you received a 30-day eviction notice or a 3-day “pay or quit”?
- Have you recently lost your housing and become homeless?

If these things are happening to you, the Federal Homelessness Prevention and Rapid Re-housing Program (HPRP) may be able to help. HPRP provides short-term rental and utility assistance for low-income individuals and families who are facing homelessness, or who are currently homeless. Even if you are not eligible for HPRP, you may be eligible for some other type of assistance.








Please call any of the core agencies or partner agencies listed on the back page to schedule an eligibility pre-screening and interview.

You must bring to your appointment:

- A copy of your lease
- A copy of your eviction notice, or the late rent notice
- Pay stubs and all income information for the last 30 days
- A valid ID
